## **Background**

We respect and value the privacy of everyone and will only collect and use personal data in ways that are described in this Policy, and in a way that is consistent with our obligations and your rights under the law. # 1. Definitions and Interpretation

In this Policy, the following terms shall have the following meanings: "Cookie" means a small text file placed on your computer or device by our Site when you visit certain parts of our Site and/or when you use certain features of our Site. # 2. What Does This Policy Cover?

This Privacy Policy applies only to your use of https://www.24.online (hereinafter – Site). Our Site may contain links to other websites. Please note that we have no control over how your data is collected, stored, or used by other websites and we advise you to check the privacy policies of any such websites before providing any data to them.

#### 3. What is Personal Data?

Personal data is defined as 'any information relating to an identifiable person who can be directly or indirectly identified in particular by reference to an identifier'. Personal data covers obvious information such as your name and contact details, but it also covers less obvious information such as identification numbers, electronic location data, and other online identifiers. Anonymous information, which we are not in a position to relate to you, does not qualify as personal data.

## 4. What Are Your Rights?

- d) The right to restrict (i.e. prevent) the processing of your personal data.
- e) The right to object to us using your personal data for a particular purpose or purposes.
- f) The right to data portability. This means that, if you have provided personal data to us directly, we are using it with your consent or for the performance of a contract, and that data is processed using automated means, you can ask us for a copy of that personal data to re-use with another service or business in many cases.
- g) Rights relating to automated decision-making and profiling. We do not use your personal data in this way.

#### 6. How Do We Use Your Personal Data?

We must always have a lawful basis for using personal data. This may be because the data is necessary for our performance of a contract with you, because you have consented to our use of your personal data, or because it is in our legitimate business interests to use it. Your personal data will be used for one of the following purposes:

- Providing and managing your access to our Site
- Personalising and tailoring your experience on our Site
- Supplying our products and services to you
- Personalising and tailoring our products and services for you
- Supplying you with information by email and/or post that you have opted-in to

With your permission and/or where permitted by law, we may also use your personal data for marketing purposes, which may include contacting you by email and/or post with information, news, and offers on our products and/or services. You will not be sent any unlawful marketing or spam.

## 7. How Long Will We Keep Your Personal Data?

We will not keep your personal data for any longer than is necessary in light of the reason(s) for which it was first collected.

#### 8. How and Where Do We Store or Transfer Your Personal Data?

We may store some or all of your personal data in countries that are not part of the European Economic Area (EEA). We store your data with external third parties, as detailed in Part 9.

#### 9. Do We Share Your Personal Data?

We will not share any of your personal data with any third parties except as directly indicated in this Policy.

#### 10. How Can You Control Your Personal Data?

You may opt out of direct marketing and manage your personal data preferences.

## 11. Can You Withhold Information?

Users may access certain areas of our Site without providing personal data, but some features may require data submission.

#### 12. How Can You Access Your Personal Data?
